In the event that the diesel price reaches or exceeds CZK 45.00 per L, a surcharge to the Fuel and toll charge will be added to the price in addition to the included basic charge. The surcharge will always be set for a specific calendar month (the surcharge applied will be the one valid for the month in which the parcel is posted). The decisive factor for determining the surcharge will be the average

diesel price (CZK per L) published by the Czech Statistical Office for the period of the last complete calendar week of the month (that is, the week in which there is no transition into a new calendar month) preceding the month in which the parcel is posted.

For the avoidance of doubt, the diesel price published by the Czech Statistical Office is a reference indicator of the overall transport costs associated with fuel and the use of road infrastructure (fuel and tolls), which are economically correlated.

- Cases where the price is agreed in a written Agreement with individual price terms, unless the Agreement provides otherwise. If the Agreement refers to this Pricelist, the Pricelist will apply to the extent set out in the Agreement, in particular as the basis for setting the price or as the methodology for determining the price. An individually agreed price takes precedence over the price set out in this Pricelist (regardless of the individually agreed price).
- Cases covered by a marketing event (discount), provided that the price set for the marketing event is lower than the price specified in this Pricelist. In such cases, the price specified for the marketing event takes precedence over the price specified in this Pricelist.

Any deviations from or additions to this Pricelist agreed under an Agreement and/or in the individual price terms must not change the nature of the service offered for the given product.

Prices are subject to change.

The above-mentioned products and the relating additional services, surcharges and discounts will only be provided under a concluded written Agreement and, where applicable, individual price terms.

A fee of CZK 20 will be charged for cancelling the posting of a Balíkovna or Balíkovna na adresu parcel at a Non-Post Office Balíkovna (cancellation can only be performed by Balíkovna staff).

The prices are quoted exclusive of VAT as well as inclusive of VAT at the current rate according to valid legal regulations.

The prices of all products have been calculated with regard to the usual average weight of posted parcels.

In the event that any service, fee, or other item is not expressly specified in this price list, its price and conditions shall be governed by the currently valid price list of Česká pošta.

Transport price and any related fees are determined by data collected during transit.
